## ITEM NO.4: EARMARKING OF THE LAND FOR PROPOSED ENGINEERING COLLEGE.

The Managing Director/ Trustee Mr. Mahesh Kumar Agarwal informed the management committee that the trust had acquired about 10.09 acres of land in the name of the trust at Village Anora, Chinhhat, and Lucknow for the engineering college project. He further informed that the planning for the Engineering College was being done in such a manner so that the academic session 2008-09 could be taken up for the proposed college. All the formalities regarding this were underway and application to the AICTE Regional Office would be made in due course along with the fulfillment of required formalities for this purpose. He further informed the committee that they had to earmark this land exclusively for the purpose of the engineering college and hence the following resolution was passed unanimously:

“RESOLVED hereby that the land as mentioned below be earmarked exclusively for engineering college project of the Trust namely ‘GOEL INSTITUTE OF TECHNOLOGY AND MANAGEMENT’. The formalities regarding mutation of land use etc. should be completed and application be made to AICTE for establishment of the Engineering College on this land. The land will also be used in future for MBA and MCA courses as per the AICTE norms, rules and regulations.”
